RECOGNITION ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, HINDUPAT INSTITUTE OF TEACHER TRAINING, RUN BY VIJAYA EDUCATIONAL CHARITIABLE TRUST, PLOT NO. - 217 AND 223/2/C, BADA BAAG, VILLAGE + P.O. + TEHSIL - RAGHOGARH, DIST. - GUNA, RAGHOGARH - 473226, MADHYA PRADESH (WRCAPP2091/223) had submitted on 27.12.2012 the application to the Western Regional Committee of the NCTE for grant of recognition for starting the B.Ed. - 2. NOW THEREFORE, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to HINDUPAT INSTITUTE OF TEACHER TRAINING, RUN BY VIJAYA EDUCATIONAL CHARITIABLE TRUST, PLOT NO. 217 AND 223/2/C, BADA BAAG, VILLAGE + P.O. + TEHSIL RAGHOGARH, DIST. GUNA, RAGHOGARH 473226, MADHYA PRADESH for starting the B.Ed. (CO-ED) Course of 1 Year with an annual intake of 100 seats from the academic session 2014-2015 under Clause 7(11) of NCTE Regulations, 2009.
- 4. Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations, 2009.
- 5. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.
- 6. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009.
- 7. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
